

## The Nishnabotna River – Southern Drift Plain Region

#### East

- 696,400 Acres
- 76% in Row Crop
- 75% of lower 100 miles straightened
- Heavily channelized

#### West

- 489,500 Acres
- 80% Cropland
- The most physically altered river in the state
- 15 ft banks, no riparian zone
- 2013 High priority for IA
   Nutrient Reduction Strategy
- Only designated Water Trail in State

#### March 9-11, 2024 Red Oak, Iowa Fertilizer Spill


- 265, 000 gallons of Nitrogen
   Fertilizer in the East Nish
- Detected down river for 60 miles
- Killed 800,000 Fish
- An unknown number of other water animals
- No remarks from NEW Coop

- DNR responded
- Clean-up
- Environmental Protection
   Commission Unanimously
   recommended AG pursue
- Since May 2024 on Brenna Bird's desk



## Friends of the Raccoon River Anniversary Shenandoah Listening Session






#### Shenandoah Listening Session

- Youth Group with 4 area Parishes


#### Ideas for Advocacy and Action

#### New Culvert for a "bad bridge"






#### Challenges


